POSITION DESCRIPTION

POSITION: Junior and Senior Class Sponsor

JOB SUMMARY:

The Class Sponsors for the Junior and Senior Class is the representative of the Principal for class activities and the school's resource person in the area of class activities and events. The Class Sponsor should foster a program of activities and service for students in conjunction with school administration and with students through the respective class council. The Class Sponsor shall enforce and adhere to the policies, rules, and guidelines of the Board of Education and the school. The Class Sponsor needs to cooperate with school administrators and to inform the principal on issues about the class that may affect the school and the class.

REPORTS TO: School Principal

QUALIFICATIONS AND EXPERIENCE:

1. Excellent oral and written communication skills
2. Demonstrated management, leadership and human relations skills
3. Ability to exercise good judgment in making decisions
4. Proven ability to carry an assignment to its completion
5. Demonstrated success in accomplishing tasks akin to the duties and responsibilities listed below
6. Such alternatives to the above qualifications as the Calvert County Public Schools may find appropriate and acceptable

DUTIES AND RESPONSIBILITIES:

1. Work cooperatively with the principal in planning events for students as designated by the principal.
2. Assist in other school activities for students as designated by the principal.
3. Hold monthly class council meetings and other meetings as necessary by activities
4. Monitor the election process for class officers and class council members.
5. Oversee and work cooperatively with other sponsors in events mutually planned for students.
6. Be responsible for recording accurately all monies collected for events and for promptly turning monies and records of monies to the principal's designee.
7. Develop sound financial plans to support student and service activities.
8. Schedule class events in accordance with school policies.
9. Assist principal or designee with class assemblies
10. Distribute as requested information related to traditional class roles such as graduation announcements and class rings.
11. Secure sufficient adults to supervise activities.
12. Coordinate prom, graduation and other activities as designated by principal.
13. Perform other duties as assigned by principal.

OTHER DUTIES:

Performs related work as required or assigned by the Principal and/or Athletic Director

PHYSICAL DEMANDS:

Position requires significant periods of standing and walking, and is performed in a typical school environment

UNUSUAL DEMANDS: None

TERMS OF EMPLOYMENT:

Salary commensurate with qualifications and experience applied to the current year Extra Pay for Extra Duty Longevity Pay Schedule.

FLSA STATUS: Exempt

EVALUATION:

Performance will be evaluated in accordance with the policy on evaluation as established by the Calvert County Public Schools.

APPLICATION PROCEDURE:

Coach/Club/Advisor application should be submitted to the Principal where the vacancy exists.

References must be directly related to work experience and must include current immediate supervisor.

State law requires that anyone hired after October 1, 1986, who will have contact with school children, must be fingerprinted and submit to a criminal background investigation. Federal law requires that a new employee must complete the Employment Eligibility Verification (Form I-9) in person before beginning employment. Employment is conditional upon successful completion of a drug screen. Current employees of the Calvert County Public Schools are exempt from these requirements.
